

tim Tariffs

Registration for a **tim** membership incurs a one-off fee of **€ 15**.

The monthly **tim** membership **fee** is **€ 9.50** (minimum term of contract: 1 year).

Do you have a valid Top-Ticket, a KlimaTicket Steiermark or a KlimaTicket Österreich?

Then your registration and the monthly membership fee are free of charge.

With your student card, registration is free and you will only pay a monthly membership fee of € 5 instead of € 9.50 until you turn 26 (the minimum term of contract is only 6 months).

RENTAL CARS

Long-term rental car use possible for all carsharing classes

10 days and up **upon request by email**

Fuel not included, km free

The following applies per booking for all carsharing vehicles:

- Fuel and electricity costs included
- 50 km free; thereafter, each additional km will be charged at € 0.25 for electric vehicles and € 0.30 for conventional vehicles
- Flat-rate weekend fee: 150 km free
- Digital motorway toll sticker and tolls for the Gleinalm and Bosruck tunnels (A9) are included
- Minimum booking period for mid-range cars: 3 hours

Delayed return of vehicle – unannounced	€ 100

Vehicle not parked properly at the tim location ³	€ 30
Vehicle returned with tank less than 25 % full	€ 30

Locking fee (unlocking and locking by the customer service department)	€ 5
Allowing access to the vehicle to unauthorised persons/transfer of the access medium (access data app, tim card, etc.) to unauthorised persons	€ 450
Handling costs	€ 15 and up
Non-commencement of travel with reserved vehicles	100 % of the current value
Unsuccessful SEPA direct debit (chargeback fees)	according to the bank fee charged
